

## 2017 OTC Tools Evolve and Encore Sweepstakes

### Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

**SWEEPSTAKES PERIOD:** The 2017 OTC Tools Evolve and Encore Sweepstakes (the “Sweepstakes”) begins at 12:00am EST February 1, 2017, and ends at 11:59pm EST April 30, 2017 (the Sweepstakes Period”).
